# Western Balkans and Europe: Sustainable and resilient rail investments for a successful extension of the TEN-T Network

#### Introduction

The integration of the Western Balkans' transport markets into the European Union (EU) represents a critical step in fostering regional connectivity, economic growth, and sustainable development. The Transport Community, in collaboration with the six Western Balkan partners, plays a pivotal role in this integration by assisting in the adoption and implementation of EU transport legislation and supporting projects that enhance connectivity within the region and with the EU.

The revised TEN-T Regulation, which extends the EU rail network to include the Western Balkans, Ukraine, and Moldova, presents significant investment opportunities. This extension is not only a strategic move towards deeper integration but also an opportunity to enhance the resilience and sustainability of the regional rail network. However, the success of these investments hinges on addressing technical challenges and ensuring that relevant EU legislation is effectively adopted and implemented.

# Objectives of the Panel Discussion

This panel discussion aims to bring together key stakeholders to explore the vision, opportunities, and challenges associated with advancing the integration of the TEN-T network with EU partner countries. The discussion will focus on the perspectives of European rail suppliers, the Transport Community, and representatives from the Western Balkan partners, highlighting the state of play and future prospects in infrastructure, rolling stock, and signalling projects. By addressing both the strategic and technical aspects of this integration, the discussion will contribute to a clearer understanding of the path forward and the steps necessary to achieve a sustainable and resilient rail network across the region.
